Public Law Outline (PLO) Toolkit

1. Introduction

The Public Law Advisory Group issued guidance to assist all those concerned with the child protection and family justice systems in England and Wales to promote improved practice and decision making in respect of pre-proceedings and public law applications.

The purpose of this Toolkit is to assist in decision making when considering whether to enter PLO and to ensure that all planning for children and young people is appropriate, proportionate and timely.

2. How to use this Toolkit

- Vital questions need to be answered to inform decision making when considering the need to issue proceedings and to endorse a care plan, taking account of the provisions of the PLO: crucially:
 - a) What is the child's chronology telling us about the risk?
 - b) What is the impact for the child or young person?
 - c) Do we need to take action now to safeguard the child and young person's welfare? and:
 - d) Do we need an Order if so which one?
- Where children face a serious and immediate risk of harm, the ability to enter court proceedings without delay is crucial in order to prevent harm, and to secure stability and / or long-term permanency.
- If a child is at *immediate risk of harm*, the court's involvement should be sought without delay. Adherence to and compliance with the PLO is required *before* a case is brought to court. However, *the safety and welfare of the child should never be put in jeopardy* by delaying issuing proceedings whether because of lack of documentation or otherwise.

- Labelling a case as 'urgent' needs to be reserved solely for situations where there is an immediate serious risk of harm.
- Where Shropshire Council does have to issue proceedings the case should be as far as is possible 'ready to go' with assessments already completed available on issue, clear statements outlining threshold and clarity around future planning.
- The toolkit list below has a number of documents to support improved decision making, for example the PLO flow chart plots the decision-making process and the relevant documents at each stage of the PLO process.
- At the end of the table list are links to guidance and resources, for example the Family Justice Board statement which outlines the need for practice and culture change. There are also some legal judgement quotes for reference.
- The toolkit should be used flexibly and dynamically the documents and resources may be updated/deleted as required.
