



Hillingdon Modern Slavery subgroup - Resource Guide

Dear partners,

Please find below the 1st version of the Modern Slavery subgroup resource guide, containing references to a variety of published statutory guidance for local authorities and public sector agencies.

Familiarising yourself and your relevant staff with the resources referred to in this document will enable working in accordance with the Modern Slavery Act 2015, with the aim to support and enable all member organisations, to appropriately refer and support (potential) victims of Modern Slavery.

In addition to this guide, the Modern Slavery subgroup is in the process of developing a Hillingdon specific referral pathway, which will be shared within the group and published on the HSCP and SAB websites (please also consider referencing in your own organisations, your websites, resources, etc.).

Please note: A safeguarding referral should always be sent to Children's Services MASH and/or Adult Social Care MASH when required, along with statutory duties related to the National Referral Mechanism/Duty to Notify Process.

The police can be called 24/7 on **999** for emergencies or on **101** for non-emergencies regarding matters relating to modern slavery and human trafficking.

The Human Trafficking Foundation - Modern slavery protocol for local authorities

Together with the London working group, the Human Trafficking Foundation has produced a protocol for local authorities containing several resources to help improve their response to human trafficking and modern slavery, in particular the identification and support offered to adult survivors.

Referral Pathway for adult victims: A 1-page 12 steps overview referral pathway for adult victims of modern slavery.

NRM process guide: This guide accompanies the Local Authorities' Referral Process Pathway for Adult Victims of Modern Slavery. This guide provides non-prescriptive steps to follow when a potential victim of human trafficking or modern slavery is identified. It should be adapted to each local authority's internal structures.

<u>Definitions and Indicators</u>: How to identify a victim of human trafficking or modern slavery.

<u>Statutory Duties and Powers</u>: The NRM and a Local Authority's statutory duties to identify and support victims of human trafficking and modern slavery.

Home Office - Modern Slavery Awareness & Victim Identification Guidance booklet (published 10/2017)

NB: This document might suit well as an initial read about the topic of Modern Slavery.

This guidance is aimed at a broad range of public sector staff who could potentially witness indicators of modern slavery, including those working in education, health, local authorities, and any other role that comes into contact with the public. The guidance may also be useful for members of the public or businesses, although they are not the primary audience. It has been produced by the Home Office with input from other Government Departments, the police, and other public sector professionals.

Home Office Statutory guidance - Modern slavery: how to identify and support victims (published 24/03/2020)

NB: This is a very comprehensive document and is about supporting both child and adult victims of modern slavery.

It covers the topic of modern slavery in many aspects e.g. by an overview of what is regarded as modern slavery, indicators, identifying victims, referring into the National Referral Mechanism/duty to notify process, ensuring immediate safety, roles of first responder and non-first responder agencies.

Additionally there are a number of annexes to support e.g. vulnerable people who might have experienced or face various challenges and difficulties, which also might impact their mental health. There also are sections dedicated to financial- and material support, legal aid, benefits, etc.

This guidance is for:

- First Responder Organisations
- Organisations with a duty to notify the Home Office when encountering a potential victim of modern slavery
- Other organisations involved in the identification of potential victims of modern slavery
- Decision makers at the Single Competent Authority
- Organisations offering support to potential victims and victims of modern slavery

The Joint civil society report on trafficking and modern slavery in the UK to the UN Human Rights Committee, 128th Session (02 Mar 2020 - 27 Mar 2020) expressed the following concern about lack of specialist training (page 7) "(...) Most First Responders in statutory organisations are not specialists and have not been trained on how to identify and support potential victims or how to complete an NRM form (and a badly written form can result in the likely rejection of a positive decision) and are often unaware that they have this role (...)".
