### Post 18 Housing Options:

**Staying Put:** continuing to live with your foster carers after the age of 18 under a Living Together Agreement

**Shared Lives:** If you have additional needs you can live with a host family who will support your independence and meet your additional needs

**Supported Lodgings:** Living with a host family who will support your independence

Supported Accommodation: Living in independent accommodation with support provided

Social Housing: Living in your own property through a Registered Social Landlord

**Privately Rented tenancy:** *Living in your own property through a private landlord*

# Supported Accommodation/Supported Lodgings Offer:

**High Priority:** 

- Under 18's who are homeless
- Children looked after who are in transition to leaving care (16/17year olds) (eligible or relevant child as defined by legislation)

# AND have a connection with Lancashire (as defined by the Homelessness Reduction Act)

# **Medium Priority:**

- Former relevant care leavers aged 18-24 years old who are homeless
- Qualifying care leavers aged 18-21 years old who are homeless
- Young people aged 18-21 years old who are homeless and were formerly assessed as a Child in Need/ Section 17 as a result of being homeless (i.e. through the Joint Protocol process)
- 18-21 year olds who are homeless and are eligible for assistance under the Care Act

AND have a connection with Lancashire (as defined by the Homelessness Reduction Act)

### Low Priority:

- 22-24 year old qualifying care leavers who are homeless and have a local connection with Lancashire and where a social care assessment identifies a need for supported housing
- 18-21 years old who are homeless and have not been previously known to social care (i.e. don't fall into any of the above categories) and have a connection with Lancashire

16-21 year children looked after or care leavers from other local authorities who are homeless and **do not** have a local connection with Lancashire as defined in the Homelessness Reduction Act

- Supported Lodgings Young people have their own furnished room in a safe and supportive home, supported by the adult householder(s) or 'Hosts' singles, couples, occasionally families. Householders provide the daily contact and support with independent living skills, and a tailored support package is provided from the provider's key worker. Particularly suitable for young people who are not yet ready to live in a more independent setting such as own flat/property, or not wanting/able to live in a group living environment.
- **Core 24/7 Services** The young person has a flat/room within a in larger (typically 6+ unit), building that typically has some communal areas. Staff on site 24-hours a day (typically with a concierge arrangement during the night)
- Visiting Support Services a) Building-based support: Support will be provided by staff either based at or visiting the accommodation. An on-call support service is provided outside of core hours. b) Dispersed visiting support: The young person will be accommodated in a flat/house typically sharing with another young person. Visiting support can be accessed during specified core hours and an on-call support service is provided outside of core hours is variable in accordance with need. The visiting support arrangements are suitable for (but not limited to) young people who are stepping-down from a more intensively supported accommodation service; or are ready for the more independent 'step down' accommodation as their first move from care and do not need to access higher support accommodation services first; or present specific needs and/or risks that prevent the Young Person from accessing core 24/7 services.
