

A legal meeting was held on the [date] and the outcome of this meeting was to arrange an important meeting to discuss this with you.












WHAT WILL HAPPEN IF YOU DO NOTHING

We would advise that it is very important for you to bring a solicitor to this meeting.

If the worries we have put in this letter continue and or do not work with us in making necessary changes, we will need to consider whether to make an application to the Court to start care proceedings. This means we may ask the court to make an Order for [name of children] to reside outside of your care until a final decision is made about [his/her/their] future.
Our concerns about [name of children] are very serious. If assessments determine that you cannot keep [name of children] safe we would first, try and place him with other people in your family rather than going into foster care. This is why it is really important that you provide us with the contact details for people within your family and friend's network
Let us know if there is anybody else in your family or friends network that you would like us to assess as a potential carer/person of safety.
