Leicestershire is a place where children can build strong foundations; be safe and belong, enjoy and achieve.



## Our pledge for children

Where children live in our long-term care, we aspire for children to grow up feeling a sense of belonging, safety and stability in their home and within the care that they receive. Permanence Panel will offer oversight and ratification of permanence care arrangements for children, though high support high challenge, and a focus on building lasting safety, support, and stability though purposeful and needs based practice.

- We will create an environment where effective practice can flourish.
- We will promote relationship based practice.
- We will build strong relationships between front line practitioners and you and your family to achieve the best outcomes for you.

### **What Arrangements We Consider**

- Children in long term foster care arrangements
- Children in Connected Carer arrangements
- Children in Residential Homes
- Additional resource requests to support stability and permanence for children. This includes -therapeutic support over and above the therapeutic fund and discretionary and capital payments.

#### **Bottom Lines**

#### All options for permanence will share a common set of desired outcomes:

- Safety and Welfare children and young people are safe and feel safe; and have improved emotional and mental health.
- Stability- children and young people live in caring and stable homes; have a secure base through which to develop their sense of belonging and identity; have positive relationships.
- Education children and young people attend school, college and are not excluded; attain good educational outcomes; achieve their potential.
- Health children and young people have their basic health care needs met and have access to medical care when they need it,
- Leisure- children and young people take part in positive activities and have fun.



Transitions - children and young people make transitions in a positive way (with confidence, skills and support to care for themselves), have access to continuing education, training or employment and are encouraged to 'stay put'.

## What sucess will look like

- Children will achieve a sense of belonging and be in their permanent family arrangements as early as possible. So creating secure and safe attachments.
- Children and families will tell us that we have made a positive difference.
- Performance indicators show improving outcomes,
- Evidenced based decision making supported by robust management oversight

### **Quality Assurance & Governance**

- An outcomes and impact plan will be developed annually by the panel and success monitored by the panel chair and Agency Decision Maker.
- Development session for Permanence Panel members to be undertaken quarterly.
- Quality Assurance activity to be undertaken by Permanence Panel annually.
- Permanence report to be completed annually by the Children in Care HOS and presented to SMT.



## **Process**

Booking permanence Panel is now completed through mosaic steps. The request can be made by the IRO following a Review or arrangement (monitoring form) or can be made by the social worker through the 'Book Permanence Panel' Step – please see the How to guide:
