Arrangements for managing the risk of unregistered schools

1. Context and scope

As a commissioner of packages of support from providers that are unregistered (i.e., are not a school registered with Ofsted) Dorset Council has in place arrangements to:

- Identify providers we have placements with that may be at risk of being classed as unregistered schools ¹
- Prompt referrers and schools who may use AP to consider the risk of unregistered provision as part of their decision making
- Take appropriate steps to investigate concerns that a provider may fall with the definition of an unregistered school

Overview of arrangements

2. Definitions

2.1 Unregistered ('illegal') school: a setting that is operating as an independent school but is not registered with the Department for Education (i.e., not just about quality or safety)

Independent or private schools provide full-time education to either:

- 5 or more pupils of compulsory school age
- at least one pupil who has an EHCP or who is looked after by a local authority
- 2.2 No legal definition of what constitutes 'full-time' education. Ofsted consider if it is **intended to provide**, **or does provide**, **all**, **or substantially all**, **of a child's education**. Relevant factors include:
 - a) number of hours per week that is provided including breaks and independent study time
 - b) the number of weeks in the academic term/year the education is provided
 - c) the time of day it is provided

- d) in practice precludes the possibility that full-time education could be provided elsewhere
- 2.3 Generally, Ofsted consider any institution that is operating during the day, for more than 18 hours per week, to be providing full-time education. This is because the education being provided is taking up the substantial part of the week in which it can be reasonably expected a child can be educated, and therefore indicates that the education provided is the main source of education for that child.
